FUTURE LAMBEAU LEAPERS AUTOGRAPH BUILDING OR 50" LCD TV RAFFLE OFFICIAL RULES

The Raffle ("Raffle") begins **August 1, 2009** and ends on **September 1, 2009** (the "Raffle Entry Period"). Raffle is sponsored by Cleary Building Corp.
